MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) entered into on the 17th day of the month of January in the year **2023**

BETWEEN

IMPEX FOUNDATION, which is registered under the Indian Trust Act, and the Registration Number is 107/1V/20212, having its registered office at 42/45 E, Panachikkal Tower, Narukara (P.O), Manjeri, Malappuram, Kerala, India, Pin: 676122, represented by Mr. Ummer P, President (hereinafter called the First Party or Impex Foundation), which expression shall, where the context so admits, be deemed to include its successors, executors and administrators of the ONE PART;

AND

KORAMBAYIL AHAMED HAJI MEMORIAL UNITY WOMEN'S COLLEGE having its head office at Narukara, Manjeri, Malappuram PIN: 676122Kerala, India (hereinafter called Second Party or KAHM UNITY WOMEN'S COLLEGE), represented by its Principal Dr Muhammed Basheer Ummathur, which expression shall, where the context so admits, be deemed to include its successors, executors, and administrators of the OTHER PART. **IMPEX FOUNDATION**, and **KAHM UNITY WOMEN'S COLLEGE**, can hereafter be also **independently referred to the First Party and Second Party respectively** and collectively referred to as the "**Parties**".

It is hereby agreed upon by both the parties involved to enter into a Memorandum of Understanding for mutual benefit, towards social commitment.

THIS MEMORANDUM OF UNDERSTANDING WITNESSED AND THE PARTIES HERETO AGREE TO AS FOLLOWS:

I.Objectives of the MoU:

1. To utilise the industry expertise/experts of the First Party to upskill youth at KAHM Unity Women's College, for overall development towards building entrepreneurs.
2. To enhance employability skills among the PG and UG students of KAHM Unity Women's College establishing industry links with the Impex Foundation.
3. To develop entrepreneurial skills among youth by training them in micro features like investment, leadership abilities, communication, finance management, marketing, and resource pooling, etc.
4. To Develop opportunities for the staff and students to work with industry experts, entrepreneurs and students of other institutions thereby working towards industry links of higher education envisaged by Higher Education Department.

III. General Terms and Conditions

1. Faculty exchange for mutual enhancement during the tenure of the understanding.
2. Premises of both parties shall be utilised to provide training/classes.
3. Student group shall be a blend of KAHM Unity Women's College wards along with interested members from the community.
4. **Qualification:** The minimum qualification of the trainees for the admission shall be Plus Two.
5. **Duration:** Duration of the training/class shall be 1 (one) year.
6. **Class Days:** Training sessions/classes shall be provided on all Saturdays.
7. **Fee:** There shall be no course fee for this program.
8. **Certification:** A course certificate shall be issued to the successful students jointly by the Frist Party and Second Party.
9. **Batch Strength:** The strength of a batch shall be 20 trainees.
10. **Minimum Attendance:** minimum 90% attendance is must.
11. In all public programs and PR programs both parties shall have equal priority.
12. There shall be no training sessions/classes on public holidays.

III. Period of MOU

1. This MOU shall come into force on 17-01-2023_ and will be valid for ...2..... years and is open to mutual revision and renewal.



IV. Trademarks

1. The parties agree that each party shall use the logo and/or trademarks and other intellectual properties of other party in promotional materials only after formal approval of the other party. This MOU shall directly or indirectly create for any party of this MOU any right, title, or interest on logo and/or trademarks to the other party.

V. Intellectual Proprietary Rights

1. The proprietary rights in relation to the study material and/or courseware provided to students/trainees/KAHM Unity Women's College shall rest with the Impex Foundation.
2. Impex Foundation is the owner of all the intellectual proprietary rights about the training material thus developed (teacher & the taught), and neither this MOU nor the training material shall directly or indirectly create for Unity College any right, title, or interest therein.

VI. Jurisdiction and Arbitration

1. In the event of any dispute or difference between the Parties hereto, the courts in Manjeri alone shall have exclusive jurisdiction to try any matter arising between the Parties here-to and accordingly both the Parties shall submit to the exclusive jurisdiction of courts in Manjeri as mutually decided at that time for this purpose.
2. Any dispute arising about any aspect of the MOU shall be settled through mutual consultation and agreement, by the Parties to this MolJ. In case a settlement is not arrived at, the dispute/s will come under the purview of the Arbitration and Conciliation Act, 1996 of India and the area of jurisdiction will be Manjeri as mutually decided at that time.

VII. Termination

1. Either Party shall have the right to terminate the MOU, if the other Party commits a material breach of any of the terms and conditions of the MOU concerned and fails to rectify the same within 30 days of being requested to do so.
2. In the eventuality of termination or non-renewal of MOU on expiry of MOU, it would be the responsibility of both parties to complete and provide its services to all students admitted for the 'Program/ Course'.

This MOU is prepared in duplicate (one for Impex Foundation and one for KAHM Unity College and comes into force on the day when both Parties have signed it.
