## **PREAMBLE:**

This Memorandum of Understanding (MOU) outlines the basis upon which Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri and the Korambayil Hospital have agreed to collaborate in providing medical treatment facility for staff and students of the **Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri** by the **Korambayil Hospital**.

**Now therefore the parties, Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri and Korambayil Hospital, agree to collaborate as follows:**

1. This MOU is intended to address the issue of providing medical treatment for the staff and students of Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri as and when required by Korambayil Hospital as per terms and conditions laid out below.
2. This MOU is valid for an initial period of five (5) years, commencing on the date of signing this MOU by the signatories of the representative institutions. The signing of the MOU will be followed by a review and assessment and may be extended on mutual agreement in writing. This MOU may not be amended or modified except with the written consent of both parties. Neither party may assign or subcontract its rights or obligations under this MOU in whole or in part without the prior written consent of the other party.
3. Either party can terminate this MOU for any reason, without liability, by giving a written notice to the other party of not less than six (6) months prior to termination. Notwithstanding the foregoing, either party may terminate this MOU at any time upon written notice to the other party if the other party: (i) materially breaches this MOU, including the terms of any Statement of Work, and fails to cure such breach within thirty (30) days after receiving written notice of such breach from the non-breaching party; (ii) ceases to do business in the normal course; or (iii) becomes or is declared insolvent or bankrupt. Korambayil Hospital may terminate this MOU at any time upon written notice to Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri if there are any changes in the regulatory, licensure or accreditation requirements or standards that, in the reasonable judgment of Korambayil Hospital, materially affect its ability to fulfill its obligations under this MOU or Korambayil Hospital's non-profit mission is jeopardized.
4. This MOU does not authorize any party, without the prior written consent of the applicable other party, to use in advertising, publicity, public communications or otherwise (including, but not limited to, any press releases, sales materials, product literature, web sites, or using the relationship with Korambayil Hospital that is established under this MOU for the purpose of soliciting funds from current or potential investors) the name of the other applicable party or its trustees, directors, officers, managers, staff members, employees, students, or agents thereof, or any trade name, trademark, service mark, symbol, or logo, or any abbreviation, contraction or simulation thereof (the "Marks"), owned by any thereof, without such party's prior written consent. For purposes of the foregoing, any reference to Korambayil Hospital will be deemed to include Korambayil Hospital's parent entity, Partners, and any of Partners' affiliated entities.

5. A written request for hospitalization (i.e. IPD) should be made by Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri. This request will be either faxed / e-mailed or hand delivered by the beneficiary and produced at the time of admission along with photo identity proof issued from Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri. Korambayil Hospital will not provide credit facility without this letter. In emergency, the patient should be treated as per the hospital norms. However the request letter will be submitted latest by next working day.
6. Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri will not be responsible for making payments for items such as special attendant charges, telephone, snacks, food and beverages etc. and must be directly collected from the beneficiary.
7. After the beneficiary is discharged from the Hospital, Korambayil Hospital shall submit the bill along with supporting documents to Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri for reimbursement.
8. Payments in respect of the Final Bills shall be made by Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri directly to Korambayil Hospital within a period of 25 days from the date of receipt of the Final Bill.
9. Korambayil Hospital shall furnish to Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri the Detailed Schedule of Charges for various services and will keep informed about any revision in the charges, which may take place from time to time.
10. The Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri beneficiary will be provided best possible treatment by the panel of consultants attached to Korambayil Hospital according to the practice parameters and clinical protocols established by Korambayil Hospital.
11. In the event of termination of the MOU, Korambayil Ahamed Haji Memorial Unity Women's College, Manjeri will be responsible for payment of bills of its authorized beneficiaries admitted prior to the date of termination of this MOU.
12. MOU can be terminated by either party by giving one month's prior notice.
13. Any clauses in the MOU can be affected as an addendum, after the written approval from both the parties.
